6. Patron Comments:

There were a number of comments from the community, therefore I will list the names of those who spoke and then summarize the context as a whole.

Speaking: Karen Hinkein, Brayden Munchel (on behalf of Ashby Jones), Luke Cottrell, Samantha Bell, Brooke Bell, Dylan Miller, Fisher Brown, Kent Fortman, Gunnar Newton, Frank Hancock, Susan Moistner, Sara Munchel, Lucius Pitcock, Michael Munchel, and Amber Rushton.

Summary:

A concern was brought up about the resignation of Chad Lieberman, stating that he has brought in more than \$4 million in grants. It is understood that you can't stop someone from leaving but did any board members reach out to him? Brent Fortman said he did reach out to Mr. Lieberman. It was asked that Special Board Meetings be more publicized in the future. The Community did not feel that they were informed about meetings concerning the bond. The board did recognize that and agreed to put out a one call 48 hours prior to meetings.

Community members, parents and students raised their concerns about the \$12 million bond project and that \$6 million was allocated to renovating the high school gym. Many felt that the bond should have been used for other things, ie: track, softball field, and classrooms.

Community members and parents criticized the lack of communication, discipline for students and support for teachers. One community member/parent emphasized the need for community involvement and unity.

7. Corporation-Department Comments

7.1 Board Comments were made by Mr. Brent Fortman.

Mr. Fortman responded to the staff's concerns, emphasizing the need for unity and collaboration among all stakeholders. He acknowledged the challenges faced by the staff and the need for additional resources and support. He also urges the community to focus on the positive aspects of the district and the efforts being made to improve education, with emphasis on the importance of communication and collaboration to address the needs of students and staff effectively. Mr. Fortman addressed the negative attitude towards the school and the impact of social media on the school's reputation, asking the community, parents, students and teachers to not do so. He continues to state that the misinformation to students from teachers is causing a separation and this needs to stop and all come together for our school and community. Mr. Fortman stated that he was frustrated with the community's perception that the board is to blame for all issues, particularly those related to discipline, and holding staff accountable. Mr. Fortman stated that the board's role is only overseeing the superintendent and making policy, it is not in the day-to-day operations.

7.2 Corporation Staff Comments

Middle School Staff, Traci Linde, Jordan Kennedy, Amber Jones and Jen Miller raised concerns about the workload of special education teacher, Jen Miller, who manages 50 students, and the lack of support for teachers. Stating that Mrs. Miller cannot service all of the students in her caseload. Kailey Winchester and Liza Bates explained the rationale for the extra caseload of students for Mrs. Miller. Liza Bates, Director of East Central Indiana Special Services, stated that she services all the area schools and the average caseload is 40, so Ms. Miller's classes are not out of line. Chad Lieberman took this opportunity to thank Brent Fortman for his sincere response to his resignation. He proceeded to inform the community of his reasons for leaving. He stated that misconduct on part of employees and some board members that he has witnessed is something that he is out of remedies for hence the reason for his resignation. Mr. Lieberman stated that he reported his findings to Mr. Stover, and subsequently watched his hands be tied by some board members. Mr. Lieberman informed the board that he has reported instances of misconduct to and or received guidance from the Indiana Ethics Commission, the State Board of Accounts, the Indiana Department of Labor and the Attorney General. Peggy Huesman, District Financial Manager, thanked Mr. Lieberman, everything he has done, stating he will be missed, not only because he writes the grants but also because of the work that is done after the grants are awarded. Mrs. Huesman stated that under Mr. Stover's leadership, the culture at the Middle/High School can be improved. She stated that it will take a lot of hard work, putting aside our differences and holding people accountable, but it can be done. She stated that Mr. Fortman mentioned what the role of the board is policy making and not administrating and that the Superintendent makes the decisions. She stated that she does not see this happening at this time with this board.

7.3 Superintendent Comments

The superintendent, Mr. Stover, reflected on his journey as a leader in the Western Wayne school district, highlighting his early appointment at 31 and his commitment to revitalizing a struggling district. He acknowledged past challenges, financial struggles, and divisions within the district but stressed the importance of unity and support among staff, the board, and the community. He strongly advocated for Mr. Lieberman, Director of Title and Grants, for his role in securing funds for the district. Mr. Stover emphasized his passion for education, starting as a teacher and working his way up to make a larger impact. He acknowledges his mistakes but asserts his dedication to making tough decisions for the betterment of students and the district. He urged community members to engage in constructive dialogue, set aside personal conflicts, and work together to support the schools. He concludes by reaffirming his commitment to students, teachers, and the broader community, emphasizing that the school system is the central force that unites everyone.
